- 1. Most of people were male, married and aged range between 45–50 years old. Their degrees of education were lower than Bachelor's degree, had their own business and average income between 7,000 10,000 baht per month.
- 2. The level of participation of community committee in administering community namely planning, assessing and participating in assessment were in moderate level.
- 3. There was a correlation between age, average income and marital status and level of community development participation in Bangsue District Community.




Fig.1 Conception framework of the research

The second step is Influence consists of two sets of training: (1) alternative solutions to community environmental problems and (2) community environmental management guidelines. The last step is determining guiding principles and controlling (Control).

It consists of 2 training sets: (1) an action plan and (2) a lesson summary and commitment. This format, when applied, is followed by an operational meeting. It was found to be a practical model for urban environmental planning. The participants had the knowledge and attitude at the 0.05 significant level. The satisfaction with the learning process was at the high level.
